STALL LOCATIONS

- 1. The Amphitheatre (Up to 26 3x3m pitches)
 - a. Main stage position
 - b. Suited for food stalls & drink stalls
 - c.Large area with highest footfall
- 2. Main Drag (Up to 25 3x3m pitches)
 - a.Near fun fair/picnic area/entrance to festival
 - b.Suited for any stall type (family friendly recommended)
 - c.On main route of festival layout, footfall will naturally pass all stalls in this area.
- 3. The Second Stage (Up to 20 3x3m pitches)
 - a. Near second stage, fun fair & one campsite
 - b. Suited for all stall type (bar & food recommended)
 - c.Second stage is expected to attract between 500-1000 people, and grab campers leaving/entering campsite

4. CAMPING SITE STALLS

a. We are looking for breakfast style stall holders for the camp sites. Serving coffee/tea/soft drinks & breakfast.

STALL PRICING

- Stalls are a fixed price for the whole weekend
- Stall pitches are 3x3m Please contact if you would like multiple pitches or have a custom size
- Power is available at all locations
- All stallholders are welcome to camp on site
- Stallholders are welcome to set up from 6am on Sat 28th June 2025, with the aim to be ready for 11am.
- Stallholders can leave the site from 11:30pm on Sun 29th June 2025, or alternatively leave by 12pm on Mon 30th June 2025.
- We are open to a trader taking on all bars in a zone. Please contact for further information.

TERMS & CONDITIONS

- Stallholders are asked to pay the initial fee upfront (for example £100 for a Zone 1 Food Stall pitch), the remaining 15% of turnover is asked to be paid within 5 working days of the Tribute Takeover Event. We ask for a copy of your sales report/PDQ terminal/till receipts for evidence of turnover.
 - We will not disclose the turnover of your business in any way and will simply be used for evidence of turnover as proof of 15% payment.
- Stallholders are asked to work with the event staff and abide by any guidance issued.
- Stallholders must ensure that gazebos/canopies are firmly tied down or weighted with, for example, sandbags.
- Stalls are asked to finish trading at 10:30pm. 24/7 security is provided by the festival during, & overnight.
- Commercial waste must be removed by stall holders.
- Stall location will be provided in advance.
- Electricity installations and connections will be under the control and supervision of the electrician employed by the Festival on site. A full list of electrical items with PAT testing certification is required for all stalls.
- A full list of equipment using Propane and Butane Gas Bottles will be required, gas must be provided GAS-SAFE suppliers.
- No traders will be allowed to use any cooking equipment unless they have:
 - a suitable fire extinguishing equipment visible and near to the cooking equipment.
 - the cooking equipment has passed a current official inspection.
- Stall holders are responsible for their own insurance and any theft, breakages, flooding, water, storm and any other form of damage to the Stall-holders' produce, equipment, stalls and machinery are the sole responsibility of the stall holders.
- Stall holders will also be held responsible for any accidents or damage caused by their equipment, stalls, machinery or produce.
- Public Liability Insurance must be held by each stallholder in the sum of £5 million.
- The stallholders agree with the Tribute Takeover Festival to indemnify Tribute Takeover Festival from and against any and all loss, damage or liability whether criminal or civil suffered and legal costs and fees incurred by Tribute Takeover Festival resulting from a breach of these conditions by the stallholders including any act of default or neglect of the stallholders' employees or agents.
- Stallholders may only sell products relevant to what has been declared on their booking form and agreed with the organisers. The organisers reserve the right to request removal of any products not previously declared.

TERMS & CONDITIONS

- Stallholders must always adhere to the Tribute Takeover Festival Environmental Policy; where possible.
- Stallholders cannot claim for compensation or reimbursement in the case of postponement or cancellation of the Tribute Takeover Festival due to matters beyond the control of such a Tribute Takeover Festival such as flood, tempest, acts of terrorism and so on.
 - The Tribute Takeover Festival retain the right to cancel the event up to a maximum of 6 weeks prior to the start date with no compensation, however, the Tribute Takeover Festival will reimburse all payments made for the stall to the stallholders within 5 workings days in the event of the cancellation.
- Any cancellation due to Covid-19 will trigger a full refund for stallholders.
- All rules, regulations and conditions may be changed by notice in writing from the Tribute Takeover Festival to the stallholder.
- The subletting or transfer of the area allocated to stallholders is strictly forbidden.
- The safety regulations set down by Kent Fire Brigade must always be adhered to. Stallholders must comply with the following regulations:
 - Fire-extinguishers to be visible and accessible.
 - All cooking and heating appliances must be positioned as to guarantee complete safety.
 - It is forbidden for any appliances to be operated on alcohol, petrol or oil.
 - In the case of liquid petroleum-based gas, the pressurised containers must be positioned in a removable and well-ventilated place. The connections to be made of red copper pipes bound by soldered silver rings.
 - Only purpose designed appliances for cooking and frying may be used, (frying appliances must be fitted with a thermostat)
 - A fire extinguisher appropriate for the fuel used must be placed near such appliances.
 - All flammable paper, packaging waste must be removed from the area around any cooking appliance immediately and stored in a fire-resistant container.
 - Flammable or toxic gas inflated balloons are forbidden.
- Stallholders must dispose of litter and waste thoughtfully and that all hot water/ grease is not disposed of directly onto the ground or grass as this will have a damaging effect. Exhibitors will be liable for any damage they may cause.

TERMS & CONDITIONS

- Stall holders may be visited by Environmental Health Officers on site to check compliance with UK Food Safety Legislation.
- The Tribute Takeover Festival GDPR Statement will be sent to stallholders and your personal information will be held and used in accordance with the Data Protection Act 1998.
- The Tribute Takeover Festival will not disclose such information to any unauthorised person or body, but where appropriate will use such information in keeping you informed of the Festival and related news, activities, and events unless you have indicated otherwise on the application form.
- We do not offer exclusivity of product type but will limit pitches by product type to ensure diversity. The Tribute Takeover Festival wishes to have as many varied styles/products available to attendees and encourage diversity.
- All stalls should be constructed and decorated to a high standard. All stalls must display the stallholders name clearly.
- Any damage to the installations, pipes, cables, or light fittings provided by must be Tribute Takeover Festival must be paid for by the responsible stallholder(s).
- Stallholders are forbidden to address visitors through either microphones or loudspeakers.
- Evidence of food premises registration to confirm which local authority the business is registered with must be provided.
- A copy of your most recent gas safety certificate must be required.
- A copy of your most recent electrical installation check must be required.
- To enable us to meet Dover District Council's Safety Advisory Group conditions for Land Hire ALL required certifications (PL & EL, Hygiene, Fire Risk Assessments, etc) must be received at the time of booking. Bookings will not be considered 'Confirmed' until all certification and full payment is received.
